2 **Public Health – Opioid Restitution Advisory Council and Fund – Revisions**

3 FOR the purpose of requiring the Secretary of Health to present decisions for the allocations
4 of money from the Opioid Restitution Fund to the Opioid Restitution Fund Advisory
5 Council; requiring the Maryland Department of Health to post on the Department's
6 website certain information regarding allocations of money from the Fund; ~~requiring~~
7 ~~at least a certain amount of the Fund to be used for a certain purpose each year;~~
8 ~~establishing reporting requirements on political subdivisions and the Secretary of~~
9 ~~Health regarding expenditures of money received from the Fund by political~~
10 ~~subdivisions;~~ and generally relating to the Opioid Restitution Fund.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 15 That the Laws of Maryland read as follows:

16 **Article – Health – General**

- 18 (a) In this subtitle the following words have the meanings indicated.
 19 (b) “Council” means the Opioid Restitution Fund Advisory Council.

- 21 (a) The Council consists of the following members:

22 (6) The [Executive Director of the Opioid Operational Command Center, or
 23 the Executive Director’s designee] **SPECIAL SECRETARY OF OVERDOSE RESPONSE, OR**
 24 **THE SPECIAL SECRETARY’S DESIGNEE;**

26 (b) [The Opioid Operational Command Center] **MARYLAND’S OFFICE OF**
 27 **OVERDOSE RESPONSE** shall provide appropriate staff necessary to support the functions
 28 of the Council.

30 (A) On or before November 1 each year, the Council shall provide specific findings
 31 and recommendations in writing to the Governor and the Secretary regarding the

1 allocations of money from the Fund for expenditures consistent with uses of the Fund and
2 considering the following criteria:

- 3 (1) The number of people per capita with a substance use disorder in a
4 jurisdiction;
- 5 (2) Disparities in access to care in a jurisdiction that may preclude persons;
- 6 (3) The number of overdose deaths per capita in a jurisdiction;
- 7 (4) The programs, services, supports, or other resources currently available
8 to individuals with substance use disorders in a jurisdiction; and
- 9 (5) Disparities in access to care and health outcomes in a jurisdiction.

10 (B) (1) WITHIN ~~2~~ 6 MONTHS AFTER RECEIVING THE FINDINGS AND
11 RECOMMENDATIONS SUBMITTED UNDER SUBSECTION (A) OF THIS SECTION, THE
12 SECRETARY SHALL PRESENT TO THE COUNCIL THE DECISIONS FOR THE
13 ALLOCATIONS OF MONEY FROM THE FUND.

26 distribution of money for the pilot program or that there is a reasonable basis for funding
27 the demonstration study with the expectation of creating an evidence-based program; and

30 [(3)] ~~(IV)~~ **(4)** evaluations of the effectiveness and outcomes reporting for
31 substance use disorder abatement infrastructure, programs, services, supports, and
32 resources for which money from the Fund was used, including evaluations of the impact on

1 access to harm reduction services or treatment for substance use disorders and the
2 reduction in drug-related mortality.

19 SECTION 2. AND BE IT FURTHER ENACTED, That on or before December 1,
20 2024, the Maryland Department of Health shall examine and report to the Senate Finance
21 Committee and the House Health and Government Operations Committee, in accordance
22 with § 2-1257 of the State Government Article, on the best process for making all of the
23 expenditures of all opioid settlement agreements entered into by the State, counties, and
24 municipal governments accessible to the public.

26 October 1, 2024.
