#### Somerset County Opioid United Team (SCOUT)

The purpose of the Somerset County Opioid United Team is to address the opioid and other drug epidemic in order to prevent overdose deaths and stop the spread of the drug epidemic in the community through prevention, outreach, education, enforcement, intervention, and treatment/recovery.

The mission of the Somerset County Opioid Unites Team is to develop a unified local strategy in Somerset County where individuals and families feel safe, secure, and supported through a system of care that emphasizes prevention, treatment, and recovery process.

# Goal 1: To Reduce the incidence and prevalence of substance use and overdoses in the Somerset County by empowering residents to live healthy lifestyles free of alcohol and drugs.

• Implement the Not My Child Community Outreach, Awareness, and Prevention model. Teach the Teacher.

• Expand availability of Vivatrol and Suboxone in Somerset County.

• Provider will be paid for uninsured

- Hire positions associated with LAA.
- Educate public on role of LAA

- Availability of Vivatrol injection prior to release. •

#### **Objective 2: Availability And Access To Prescription Medications** Strategy:

- Educate prescribers on PDMP.
- Increase utilization of Drug Take Back Boxes.

### **Objective 3 : Access To Narcan To Reverse Overdose**

Strategy:

- Deliver Narcan certification throughout the community.
- Provide medication at no cost for certificate holders.
- Offer weekly Narcan drop-in training at Recovery and Re-entry Center.

#### Goal 4: Reduce the prevalence and incidence of underage and binge drinking in Somerset County.

#### **Objective 1: Access And Availability Of Alcohol**

Strategy:

• Increase retail sales compliance regarding sale of alcohol to minors.

#### Goal 5: Reduce Incidence of Marijuana Use Among High Risk Populations/Especially **Adolescents and Young Adults**

#### **Objective 1: Decriminalization of marijuana is perceived as declaration that marijuana is** harmless.

• Develop and implement comprehensive media campaign that targets high risk populations (teens & young adults, family history of addiction, mental health diagnosis, pregnant women

Goal 6: Create a safe environment in the community where individuals in recovery can continue to address their recovery needs.

# **Objective 1: Addiction Is A Chronic Disease That Requires Engagement In Sober Support Systems To Prevent Relapse.**

- Stakeholder State Agencies, such as MEMA
- Community Faith Based
