Fiscal Year 2025 Competitive Grant Program *Award Summary*

About the Competitive Grant Grant Program

Maryland's Office of Overdose Response distributes approximately \$6 million annually through our Competitive Grant Program. The purpose of our Competitive Grant Program is to distribute grant funding to the highest-scoring proposals received from state and local governments and community-based partners that serve to address unmet and urgent overdose-related needs around the state.

Programs funded through our Competitive Grant Program were evaluated using a uniform set of criteria that assess potential impact and alignment with our five policy focus areas of *Prevention*, *Harm Reduction*, *Treatment*, *Recovery*, and *Public Safety*.

Additionally, for the 2025 fiscal year, Maryland's Office of Overdose Response identified six priority projects that would be prioritized during the scoring process. These include:

- evidence-based and promising practices for early childhood prevention interventions;
- expanding access to evidence-based treatment and harm-reduction services for at-risk populations;
- transportation to treatment, harm reduction, recovery services, employment, and essential government services;
- peer programs in libraries and other community settings;
- supporting employment in recovery; and
- extended stays in certified recovery residences.

Our office received 154 applications for funding totaling over \$35 million in requested funds for this fiscal year. Following the evaluation by our multiagency, multidisciplinary evaluation committee, 38 of the top-scoring proposals were awarded for a collective total of \$6.23 million. Over half (24) of our awardees were community-based or non-profit organizations and 11 were local government partner organizations.
