### Penn North High Intensity Residential



- ASAM 3.5 High Intensity Residential Program for Returning Citizens
- HG §8-505 and §8-507 Court Ordered Treatment for individuals in the correctional system with substance use disorders
- Reduces Overdose Deaths among our Returning Citizens, a population who is very high risk for overdose death
- Provides Treatment, Education, and Recovery Support
- Property is a 7-bedroom facility with capacity for 14 individuals



#### Penn North Medium Intensity Residential

- ASAM 3.3 Medium Intensity Residential Program for Returning Citizens
- MDH Behavioral Health Administration's Gender Specific Services Unit certified our program as a Pregnant Women and Women with Children Specialty Provider
- Reduces Overdose Deaths among Mothers/Parents, which can also lead to Infant/Child deaths
- Property is a 8-bedroom facility with capacity for 16 individuals



#### Penn North PWWC Program

- BHSB Provides grant which partially covers childcare for the 8 families who participate in the Medium Intensity ASAM 3.3 Program
- Women with Children Programs are Especially Expensive to run because:
  - The Children take up bed space which could otherwise be used by a Medicaid billable patient
  - Traditional Medicaid Reimbursement does not cover childcare
  - Our staff spends countless hours going back and forth with the funder (BHSB) over minutia related to what is reimbursable and what's not



### Recent Developments in Behavioral Health

- SUD (Substance Use Disorder) and Mental Health have merged to become "Behavioral Health"
- Most SUD Patients have co-occurring SUD and Mental Health disorders, and often need additional increased Medical Care as well (aging population)
- Emphasis on treating the "Whole Person" Holistic Approach
- Acute Need for Integrated MH and SUD Services
- Increase in Wrap Around Services



### Services Provided by Care Coordinators

- Conduct initial assessment, medical, mental health and substance use history
- Complete intake paperwork and consent forms
- Identify participant goals, needs, strengths and potential barriers to care (financial, transportation, medical etc)
- Schedule medical, mental health and counseling appointments.
- Central point of contact between participants, healthcare providers and community services
- Coordinate appointments, treatments and follow-up care
- Help resolve issues with insurance, housing or benefit



# Services Provided by Care Coordinators (cont.)

- Refer participants to outside providers (specialist, dental and psychiatric care, MAT programs)
- Provide participants with community resources such as food, housing, transportation, and mental health services.
- Make referrals to support groups or social service agencies.
- Help apply for public benefits (Medicaid, Snap, SSI, etc.)
- Identify and manage crisis (medical, mental health, or social)
- Maintain accurate records of care plans, interactions and services provided.
- Participate in quality improvement initiatives
- Conduct follow-up after discharge to monitor continuity of care.



### Criminal Justice Care Coordinator services

- Collect participant demographic, legal and criminal history
- Review court orders, probation/parole conditions, and sentencing requirements
- Obtain necessary ROI to communicate with justice entities
- Orientate participate to treatment program expectations and legal compliance obligations
- Assist participants with obtaining access to housing, employment and education to reduce recidivism risk



# Criminal Justice Care Coordinator svcs (cont.)

- Connect participants to supportive services (ID reinstatement, expungement support, vocational training.)
- Help participants prepare for legal obligations such as court hearings, documentation, progress reports.
- Educate participant on rights, responsibilities, and available reentry supports.
- Ensure probation/parole officers receive continuity of care updates at discharge.





### Future Organizational Facilities Needs

- Peer Services Center need office space for 8-10 Certified Peer Recovery Specialists, plus Supervisors and Administrative staff
- Mental Health Therapy (OMHC) need office space for mental health therapists, space to become the future Behavioral Health Urgent Care Center (BHUCC), future Mental Health Crisis Services
- Methadone (OTP) and Medication Assisted Treatment (MAT) Clinic need long term solution to provide MAT internally, rather than through partners
- Inpatient Facility need facility for long-term inpatient/residential treatment, highest level of care requires specialized facility



#### July 2025 Overdose Response

- July 10, 2025 26 overdoses occurred almost simultaneously near the corner of Pennsylvania Ave and North Ave. Penn North was among the first on the scene to respond.
- July 10 -11, 2025 and to present The community has seen an outpouring of support from organizations all over the city and state. Harm Reduction based organizations and others have stepped up their presence in the Penn North community to help with the response and provide support.
- July 18, 2025 second round of overdoses near McCulloh St and North Avenue.
- July 23, 2025 third round of overdoses near Laurens St and Penn Ave.
- Current Status State of Maryland and Baltimore City working together to create
  a more coordinate effort to respond to overdose incidents.
